## 2.1 Access


The open innovation environment has three levels of access. The first level is public and can be accessed through the website <a href="www.mmama.eu">www.mmama.eu</a> under OPEN INNOVATION PLATFORM.



The second level of access is for stakeholders and it is realized with a webdav account. All project partners and stakeholders have read and write access to this webdav share. The webdav account can be linked to a network drive and thus it can be accessed like any other folder on a personal computer. 
